### **DIRECTIONS FOR USE:**

For use UNDER fresh litter, straw, shavings, sawdust and bedding. Using spreader equipment, apply at a rate of 1 US pound (16 oz) per 1000 square ft of area (length x width = area).

For deep drain applications (sewer drain, septic, waste water treatment, RV, etc) mix 4 lbs of MB-G per 4 1/2 gal of warm water. Stir and let set for 20 minutes. Stir before each pour and apply all contents into the drain system. Use within 24 hours of mixing.
